PUBLIC NOTICE

The statutory requirements for meetings under the Local Government Act 1972 ('the 1972 Act') could not be met during the Coronavirus pandemic. As a result, s78 of the Local Authorities and Police Crime Panels (Coronavirus) (Flexibility of Local Authority and Police and Crime Panel Meetings) (England and Wales) Regulations 2020 ('the 2020 Regulations') came into force which enabled the Town Council to hold meetings remotely.

Although these Regulations have now ended and physical meetings need to resume, ongoing restrictions limit the number of attendees at the Town Hall. Therefore, the Town Council will continue to stream Town Council Meetings using Zoom software but members of the public may attend the meeting if they wish to speak in Public Participation or observe the meeting in person.
