Recording of meetings by Press and the Public

Recording is not allowed when the meeting has agreed to formally exclude the press and public due to the nature of business discussed. Unless agreed otherwise in advance, recording and reporting must take place from the public seating area and should be overt and focused on those speaking at the meeting, not other members of the public.
