

**ORDER UNDER SECTION 21 OF THE
TOWN POLICE CLAUSES ACT 1847
FOR THE PREVENTION OF OBSTRUCTION IN STREETS**

**ROAD CLOSURE ORDER NUMBER NO. 13 - 2019
SHAKESPEARE BIRTHDAY CELEBRATIONS 2019
Saturday 27 April 2019**

During certain hours on Saturday 27 April 2019 Henley Street, Meer Street, Bridge Street, High Street, Union Street, Wood Street, Waterside, Southern Lane, Sheep Street, Chapel Street, Church Street, Old Town and Chapel Lane, Stratford upon Avon ("the Streets"), will be thronged or liable to be obstructed on the occasion of the Shakespeare Birthday Celebrations.

In pursuance of the powers conferred upon it by Section 21 of the Town Police Clauses Act 1847, Stratford-on-Avon District Council of Elizabeth House, Church Street, Stratford-upon-Avon aforesaid do HEREBY ORDER AND DIRECT that for the purpose of preventing obstruction in the Streets on the said day the following Regulations shall be observed:-

1. Save as provided in Regulations 2 and 3 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, drive, ride or propel any vehicle, or cause or permit any vehicle to wait on or in the Streets between 07:00 hours to 13:30 hours on Saturday 27 April 2019.
2. Nothing in the Regulation 1 of this Order shall apply to any vehicles being used for Police, Fire Brigade or Ambulance purposes in the exercise of statutory powers or duties.
3. Any person directed or permitted by a police constable in uniform to drive, ride or propel or to cause or permit a vehicle to wait on or in the Streets during the said hours on the said day shall comply with the direction of the police constable and of any other police constable in uniform.
4. All persons present in the Streets during the said hours on the said day shall comply with the directions of any police constable in uniform.
5. Willful breach of this Order is an offence and any person committing such an offence shall be liable to a fine not exceeding One Thousand pounds.

SHAKESPEARE BIRTHDAY CELEBRATIONS – SUNDAY SERMON
Sunday 28 April 2019**

During certain hours on Sunday 28 April 2019, Sheep Street, High Street, Chapel Street, Church Street and Old Town, Stratford upon Avon ("the Streets"), will be thronged or liable to be obstructed on the occasion of the Shakespeare Birthday Celebrations – Sunday Sermon.

In pursuance of the powers conferred upon it by Section 21 of the Town Police Clauses Act 1847, Stratford-on-Avon District Council of Elizabeth House, Church Street, Stratford-upon-Avon aforesaid do HEREBY ORDER AND DIRECT that for the purpose of preventing obstruction in the Streets on the said day the following Regulations shall be observed:-

1.
